The Federal Rules of Evidence (eff. Dec. 1, 2018) govern the admission or exclusion of evidence in most

proceedings in the United States courts. The Supreme Court submitted proposed Federal Rules of Evidence to Congress on February 5, 1973, but Congress exercised its power under the Rules Enabling Act to suspend their implementation.
